#### 15. Multidisciplinary / interdisciplinary

R.A. Podar College, a distinguished institution focused on Commerce education, has been a leader in higher education since its establishment. In the 2019-20 academic year, the college introduced the B.Com in Actuarial Studies program under its autonomous framework, offering a curriculum that integrates disciplines such as Mathematics, Statistics, Economics, and Finance to prepare students for the assessment and management of financial risk. In pursuit of its vision to evolve into a multidisciplinary institution, the college launched three new undergraduate and three postgraduate programs in 2022-23. Currently, the college offers a diverse range of six undergraduate programs, including B.Com, B.Com (Actuarial Studies), BMS, B.Sc. (Data Science), BBA (Shipping and Logistics Management), and B.Com (Financial Markets). At the postgraduate level, it provides five M.Com programs specializing in Accountancy, Business Management, Behavioral Finance, Business Analytics, and International Business. Furthermore, it offers four Ph.D. programs covering fields such as Banking & Finance, Business Policy & Administration, Commerce, and Accountancy. A key feature of the college's academic structure is the mandatory "Responsible Citizenship" course, which all final-year students undertake. This course is designed to instill a strong sense of ethical responsibility, with a focus on fostering socially and environmentally responsible behavior among students.

#### **16.Academic bank of credits (ABC):**

The College has registered for the National Academic Depository (NAD) as well as the Academic Bank of Credit (ABC). The College has uploaded data for the academic year 2023-24. It is mandatory for all students enrolled at R.A. Podar College to have an ABC ID. Information and guidelines regarding registration for ABC ID is uploaded on the college website.

#### 17.Skill development:

The college is deeply committed to enhancing students' employability through a wide range of forums and credit courses. With over 40 college forums, students have numerous opportunities to refine their soft skills and leadership abilities. These forums provide a dynamic space for meaningful discussions, debates, and collaborative activities, promoting both personal growth and professional development. In addition to forums, the college offers credit courses designed in line with the National Skills Qualifications Framework (NSQF), aimed at equipping

students with practical, industry-relevant skills. By aligning these courses with NSQF, the college ensures students earn industry-recognized certifications and are well-prepared to meet workforce demands. Students can opt and complete online courses which is approved and validated by the College.

### 18.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)

Since the 2023-24 academic year, the college has integrated the Indian Knowledge System into the first-year curriculum as part of its implementation of NEP 2020. This syllabus introduces students to India's rich disciplinary heritage across fields such as architecture, science and technology, nature, astronomy, agriculture, and health and medicine. It highlights notable Indian contributions, such as the invention of zero in mathematics and advancements in health practices through Ayurveda, meditation, and yoga. At Podar, there is a strong emphasis on preserving and promoting Indian languages. Various literary circles actively celebrate the importance of Indian languages through events like Hindi Diwas, Marathi Rajbhasha Din, and Gujarati Language Day. The college also honors Indian culture, traditions, and festivals with events like Gurupournima, Ganeshotsav, Raas Rang, Satyanarayan Katha, Bhajan Sandhya, and Bhondla, which showcase the vibrant essence of Indian heritage.

#### 19. Focus on Outcome based education (OBE): Focus on Outcome based education (OBE):

The College has fully adopted an Outcome-Based Education (OBE) framework for all programs. This approach ensures that the curriculum and teaching methods are directly linked to specific learning outcomes. The College has defined clear Program Outcomes (POs) and Program Specific Outcomes (PSOs) for each program, based on the vision and mission of the College. The POs, PSOs are uploaded on the college website. The Course Outcomes (COs) for each course are directly linked to these POs and PSOs. The curriculum is carefully designed to achieve these outcomes, incorporating a balance of core and elective courses, including interdisciplinary subjects. The College through the credit courses offer various learning experiences like blended learning through online platforms (NPTEL, Swayam, Coursera). The College prioritizes student engagement and success by orienting students on OBE during the induction programs. The College conducts Faculty development workshops to enhance teaching practices. An initiative has been introduced to map the COs with different levels of learning. During the academic year 2023-24, the Academic Cell organized a seminar on "Outcome-Based Approach in

#### 20.Distance education/online education:

The College encourages blended learning. The college has recognized the benefits of online learning and continues to leverage digital platforms to offer remedial coaching online. This approach allows students to receive additional support and catch up on missed learning opportunities, regardless of their physical location. Students are given an opportunity to pursue online courses to complete their 12 non academic credits towards completion of their degree while learning from a remote location, giving them greater flexibility and convenience. The faculty members use of innovative and digital teaching tools to foster online education. The faculty members creates E-Content, uses platforms like MS teams, Google classrooms, Zoom to conduct lectures.

The college's curriculum framework addresses development needs at local, regional, national, and global levels, promoting academic rigor and relevance to social and environmental contexts. # 2.5.3 - IT integration and reforms in the examination procedures and processes including Continuous Internal Assessment (CIA) have brought in considerable improvement in the Examination Management System (EMS) of the Institution

The examination process since the academic year 2022-23 has been automated through the ERP system and the usage of SAFE IITB for formative assessment. Established practices, such as preparing three sets of question papers per course per exam to ensure fairness through confidential selection, were retained.

#### Key reforms included:

- Ensuring balanced representation of the curriculum.
- Accurately evaluating learner performance.
- Mapping question papers to Program and Course Outcomes.
- Involving an external Question Paper Review Panel for rigorous evaluation, thereby enhancing the credibility, transparency, and accountability of the examination system.

To maintain confidentiality, question papers were printed internally, minimizing risks of leaks and unauthorized access. Model answers and marking schemes addressed grading disparities, while a decentralized system with facilitators supervising semester-end exams improved efficiency and reliability.

Additional measures to ensure equity included the masking, encoding, and decoding of answer booklets during evaluation, safeguarding confidentiality and promoting fair assessment. Special provisions were made for final-year students, including additional examinations which expedited result publication.

Support for learners with disabilities included technological assistance for visually impaired students and concessions tailored to their needs. A pledge was read before each exam to reinforce adherence to rules and integrity.

#### 4.1 - Physical Facilities

4.1.1 - The Institution has adequate infrastructure and physical facilities for teaching-learning, viz., classrooms, laboratories, computing equipments, etc.

Established in 1941, the Gothic-style college building, featuring a prominent clock tower, is recognized as a heritage site by the Municipal Corporation of Greater Mumbai. The 0.94-acre campus is is a four-story building and houses 32 classrooms, 5 labs, along with conference room, all equipped with ceiling projectors and ICT facilities to enhance the learning experience.

Two language laboratories, equipped with advanced IT hardware and cloud-based software, enhance English communication skills for vernacular students and local language proficiency for faculty. Additionally, two computer laboratories are outfitted with software for teaching R, Python, spreadsheets, Plateau, and other programs.

A fully automated library, operational since 2004, supports remote access, home lending, reference services, current awareness services, inter-library loans, and access to online resources such as INFLIBNET.

To embrace technological innovations, the college features a Video Conferencing Room, a FINTECH Lab, and an Innovation and Incubation Cell. A soundproof, air-conditioned Faculty Facilitation Room is equipped with a 65" smart interactive board, high-end laptops, digital cameras, microphones, and recording systems, enabling digital content creation, video recording, lecture filming, and live streaming.

Recognizing the constraints of limited open spaces in central Mumbai, the college collaborates with nearby institutions to expand sporting opportunities. Students have access to badminton, shooting, and boxing facilities at Ruia College, cricket net practice at Matunga Gymkhana, and basketball at Indian Gymkhana.

The college's own spacious 10,000 sq. ft. playground accommodates volleyball, field events, and cricket net practice, equipped with a heightened fence, restrooms, and spectator stands. Additionally, Lata Kunj, a nearby expansive area, enhances extracurricular opportunities for various sports and cultural activities. These facilities highlight the college's commitment to holistic student development and overall wellbeing.

Nearly the entire library collection, excluding passive materials, has been barcoded for efficient tracking and management. An ARGOX barcode printer with advanced configuration supports in-house barcoding, while three scanners facilitate seamless transactions. Students are issued barcoded borrowing tickets to enhance process efficiency.

The library boasts an extensive collection of 90,000 books, 10,000 e-books, subscriptions to 5,000 journals, and access to 20 databases, significantly enriching research opportunities for students and faculty. These technological enhancements ensure the library remains a dynamic and essential resource hub for the academic community.
